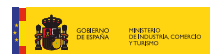

Dear Members,

The annual report provides the perfect opportunity for us to get closer to our members and patrons, in order to share with them our achievements and experiences from the past year. It also provides us with the opportunity to take stock and to take a moment to reflect.

The report indicates the robustness of our organisational structure, the loyalty of our members and the ability of the Spanish Chamber of Commerce in the UK to adapt. 2018 was a highlight in our Chamber's history as we modernised our legal structure and became a limited partnership: a change which will allow us to work in a more efficient and transparent way, thus guaranteeing the rights of all of our Members.

In 2018 we said goodbye to our dear Javier San Basilio, who was not able to continue in his position as President of the Chamber due to an unsustainable workload. It was an honourable and honest decision which was understood and accepted by us all. Last year we consolidated our institutional strategy, as not only did we welcome The Rt. Hon. Greg Hands MP to our Annual Reception but also Cabinet Minister The Rt. Hon. David Lidington, who just hours before the famous Chequers meeting was enjoying dinner with us after the 131st Annual General Meeting. Many of us remember his brilliant speech and the eloquence with which he delivered it.

Later in the year we additionally received a special visit from the Spanish Government's Minister of Economy Ms. Nadia Calviño, as well as the Minister of Industry, Trade and Tourism, Ms. Reyes Maroto; providing a fantastic example of the new Chamber's institutional profile. Meanwhile in Madrid during our first talk on Brexit held in Spain, we shared ideas with the Minister of Foreign Affairs Mr. Josep Borrell, and once again with Minister Maroto. Our ever increasing relationship with the Chamber of Commerce of Spain, based in Madrid and led by Ms. Inmaculada Riera, has resulted in more strategic activities and events, a new relationship that is already paying off and will continue to be extremely positive for all of our members.

Separately, the Spanish Financial Forum which belongs to the Chamber and is chaired by Mr Antonio Oporto has now been active for four consecutive years. In 2018 we welcomed excellent British speakers who shared their valuable ideas and reflections with the forum's Spanish participants. In addition, we launched our Human Capital Forum with enormous success, and look forward to continuing with this initiative in 2019. At the other end of the spectrum we have worked harder to maintain a busy and interesting schedule of networking events, workshops, seminars, lectures and other activities for the small and medium sized enterprises which make up an invaluable part of the Chamber's network.

We finally said goodbye to 2018 with a record number of guests and corporate tables at our annual Gala Dinner in November, at which we welcomed Mr. Francisco Riberas, Executive Chairman of Gestamp as our Guest of Honour. The extraordinary evening clearly highlighted the prominence of Spanish companies operating in the UK as well as the unfaltering relationship between both nations.

The Chamber does not cease to develop and implement new initiatives. We remain alert and consistently adapting to the needs of our members. CHANGE OF LEGAL STATUS AND ELECTION OF A NEW PRESIDENT

At the last Annual General Meeting of the Chamber that took place on Thursday 5th July 2018, members approved the incorporation of the Chamber into a private company limited by guarantee.

The previous legal status was obsolete and contrasted with the legal regime of other chambers of commerce in the United Kingdom. Operating as a company limited by guarantee is a legal structure frequently chosen by not-for-profit organisations like the Spanish Chamber, which are made up of members as opposed to shareholders.

The new Chamber is operating in the exact same way as before and as a member you will not notice any difference -it is simply an update of its legal status. The services and support provided by the Chamber to its members will therefore be completely unaffected by the implementation of these changes.

Also in July and following three years as President of the Spanish Chamber, **Mr. Javier San Basilio** handed over the role to **Mr. Eduardo Barrachina**, who until this point had been the Chamber's treasurer. Mr. Barrachina is a Spanish and English qualified lawyer at the leading international law firm White & Case LLP.

We would like to thank Mr. San Basilio profusely for all his hard work and support to the Chamber over the past few years and wish the best of luck to our new President Mr. Barrachina, with whom we are excited to get to work.

Under this principle, we provide both member and non-member companies with a wide range of services, including information and support, promotional activities and networking events.

Whether a SME or a branch of large multinational, we work meticulously to offer holistic expertise and advice, striving to find tailor-made solutions for the specific needs each company has upon first approaching us. Our enthusiasm and ability to adjust to different business realities has allowed us to significantly grow as an institution since our first establishment.

VISIBILITY AND PROMOTION

The Chamber offers commercial promotion opportunities through a wide range of services, while our events enable companies to develop their professional contact networks. In addition, we are able to provide access to essential information regarding the Spanish and British markets and offer technical and logistical support. Below are some of the principal benefits of becoming a member of the Spanish Chamber of Commerce:

- 1** All members have their contact details published on our website www.spanishchamber.co.uk, in the **Member Directory** section. This is one of the most visited sections of our website, not only by companies but also by individuals.

- 8** The corporate events that we organise offer frequent **sponsorship opportunities**, providing another path for your company to gain significant exposure. Examples of 2018 events with sponsors include our prestigious Annual Gala Dinner and the international wine tasting event held alongside other London- based foreign chambers of commerce.

COMMERCIAL SERVICES

The Chamber offers a wide variety of services which aim to improve the bilateral trade relations between Spanish and British companies. The principal trade services are:

List of companies

The Chamber can compile lists of companies by filtering the information according to the desired business sector. All lists include the name of the company, postal address, telephone number, fax number, general email address and website.

Commercial presentations

This service aims to provide an overview of the market by presenting the products of the contracting business to potential customers or partners. The aim is to establish an initial contact with potential clients or commercial partners.

Market reports

This service delves into the British market, helping the contracting company to understand the main features of the sector as well as the channels, barriers and even potential customers and competitors. This service serves as a starting point for assessing the suitability of the creation of a trade agenda, or other trade actions.

Commercial agendas

The objective of this service is to establish face to face meetings with relevant businesses whose activity is related to that of the contracting company.

Trade missions

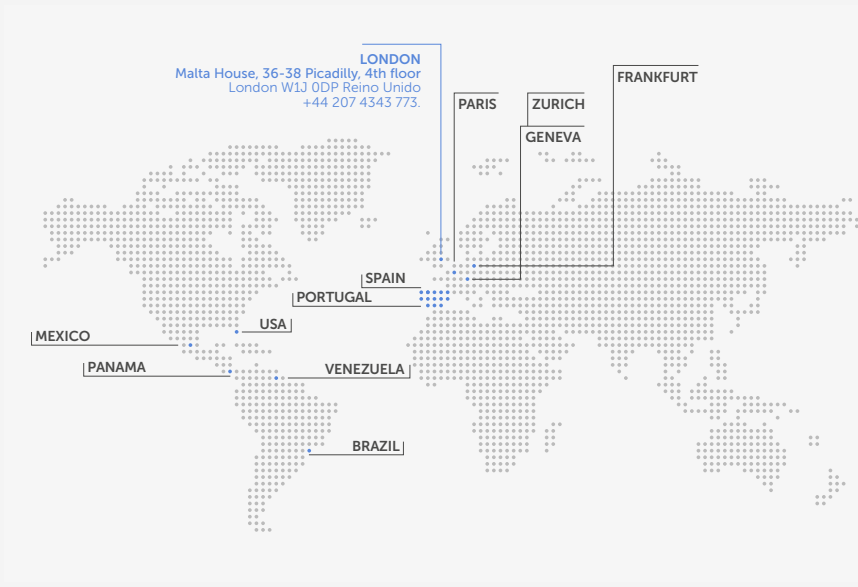

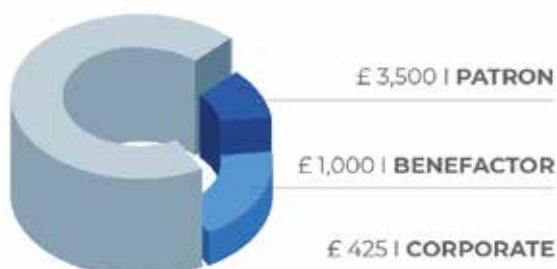

Each occasion provided a perfect opportunity for our guests to catch up with other members while enjoying one of Spain's most renowned beers and a selection of delicious Spanish tapas.

WORKSHOPS AND SEMINARS

The Chamber's aim is to promote commercial exchanges, acting as a link between companies and providing new business opportunities. Our seminars and workshops allow companies to develop and expand their networks while gaining a great deal of guidance on how to expand their personal and professional skillsets.

The first half of 2018 played host to an array of interesting seminars. In true New Year's fashion, we kicked off in January with a seminar that focused on "Accomplishing your 2018 New Year's resolutions" led by member company **The Client Academy**, who inspired us as to how we could achieve meaningful goals in the year to come.

In February, our next seminar faced a topical issue that affected a huge number of companies worldwide in 2018. "Are you ready for GDPR?", led by **SCA Ontier**, and **Technorizon UK**. They explored important points surrounding the new regulations including how data should be stored and tips for how to proceed in the future.

One month later, we tackled another current issue that has made headlines this year; the gender pay gap, in our seminar "The importance of knowing your organisation's gender pay gap" led by our member **Diversitas Institute**. We explored the root causes of this problem such as part-time work and gender discrimination, as well as ways in which we can raise awareness and work towards a fairer society.

In spring we organised two more seminars that dealt with technical issues that allowed us to examine ways in which we should be "Staying Safe Online" and how we can be "Using Social Media Data for Business Growth". **Technorizon UK** highlighted common risks such as using public wifi hotspots and not regularly changing our passwords while **Audiense** shared with us how social media data, when analysed correctly, can contribute to business growth and development.

After the summer, we organised our very first **webinar** in collaboration with Chamber member **AFEX**. During the session we learnt about different strategies regarding risk management within the context of Brexit.

In October we held the seminar, "How to optimise business outcomes through innovation with data" alongside our member **Elastacloud** and in November we hosted the final workshop of the year with our benefactor **Stevens & Bolton**, which focused on the latest updates in relation to Brexit and its impact on EEA nationals living in the UK.

All of our seminars were great eye-openers to topical issues and were well received by all; prompting a great deal of discussion and debate. Attendees left feeling more knowledgeable and motivated both professionally and personally.

ELEVATOR PITCH

The Chamber's four Elevator Pitches proved to be, yet again, one of our most popular events of the year. Last year we had the pleasure of organising them in collaboration with our member companies **Ibérica Restaurants**, **H10 London Waterloo** and **The London School of English**.

At these events participation is limited to one representative per company and a maximum of 16 companies can attend, with no more than two companies from the same sector taking part. Each participant has two minutes to give a concise presentation summarising their company's activities to the other attendees. Following this, everyone has the opportunity to ask any questions and learn more about each company followed by a late breakfast during which participants can network more informally.

We were delighted to welcome almost 50 different companies from a wide variety of sectors to our Elevator Pitches in 2018 and we consider it a fantastic way to help companies to efficiently expand their business networks in a short amount of time.

COMMERCIAL ACTIVITIES 2018

Over the course of 2018, the Spanish Chamber of Commerce in the United Kingdom carried out a total of 24 commercial ventures sharing the common objective of promoting the activities, products and services of Spanish companies operating in the British market and vice versa.

The distribution of these commercial activities was: six inward trade missions, five outward trade missions, four commercial agendas, two commercial presentations and seven sectorial sessions. Amongst these, the main sectors were food & drinks, information and communication technology (ICT) and construction.

A key section of our foreign trade activities were carried out in collaboration with various regional Chambers of Commerce in Spain, as well as “foreign promotion institutions” and private companies whose activities are primarily focused on assisting Spanish companies in the process of internationalisation.

As one of the **most successful examples** of 2018, we would like to highlight the trade mission that was organised in October in collaboration with the Chamber of Commerce of Cantabria and the regional business development organisation, SODERCAN.

This mission, in which almost 20 Spanish companies were interested, ended up welcoming representatives from 11 companies with very high interest in the UK, having organised personalised agendas in each case. More precisely, this mission took place from the 8th-11th October, both in London and across the UK, with a total of 25 meetings having been arranged for the visiting companies.

The 11 companies had the chance to discuss their business opportunities in the UK, as well to introduce their products to a wide range of potential new clients. To sum up, the arranged meetings facilitated introductions that we hope will evolve into long-standing commercial relationships between both sides.
